Dear Candidate,

Many misunderstand **the actual issues behind the Right to Life debate.**

It is first important to understand that the *Roe v. Wade* and *Doe v. Bolton* decisions of January 22, 1973, authorized abortion in all 50 states—***by defining and protecting who would perform these acts. They were to be done only by medical professionals.***

Until 1973, every state regulated the practice of medicine according to the principles of the Hippocratic Oath, the foundation of medical ethics since antiquity. But ***Roe and Doe*** struck down these ethical standards and dismissed the Hippocratic Oath as dated and irrelevant. ***In doing so, the Court severed medical law from its moral foundation—the duty to 'do no harm.'*** ***After Roe, in the United States, medical science could be used to intentionally harm.***

"I will give no deadly medicine, even if asked. Similarly, I will not give a woman medicine that causes an abortion." ***The Hippocratic Oath***

The Dobbs decision of 2022 did not address the High Court's profound legal dismissal of ethical standards in medical statutes. The Court merely admitted that under *Roe*, they had assumed the role of 'lawmakers' for the States. They then returned authority over abortion laws to the states. States could do whatever they want. But there was no Supreme Court commitment or comment on the ethics of human killing by medical science. ***Roe's*** ethical implications regarding killing human babies remains untouched.

Roe fundamentally altered the practice of medicine in the United States. It made the intentional killing of a human being an accepted medical act—an inversion of the healer's vocation. **Until this moral wound is understood and addressed, the pretense that *Roe* is 'overturned' remains a dangerous misunderstanding.**

Please review the following questions carefully. Your answers will help clarify your understanding of these vital issues and your commitment to restoring the principles of true medicine—care and protection for the vulnerable innocent.
