Vote NO on Proposition 45

When the government limits by law what can be charged for health care, it limits what people are allowed to pay for health care. While everyone would prefer to pay less – or nothing – for health care (as for anything else), government price controls in fact prevent access to life-saving medical treatment that costs more to supply than the price set by the government. The same is true when price controls are imposed on what people are permitted to pay for health insurance.

Proposition 45 gives one politician, the Insurance Commissioner power to impose price controls over co-pays, deductibles and benefits on insurance policies purchased by individuals and small businesses. It also adds a tax to all these policies to pay for the new bureaucracy needed for administer the program. Large group policies and government plans are exempted.

Currently, the Insurance Commissioner may review rates but does not have the power to place government controls on them.

Proposition 45 recklessly places the health insurance benefits of millions of Californians in the hands of one politician. Treatment decisions should be made by patients not one politician.

Vote YES on Proposition 46

Proposition 46 provides greater accountability for irresponsible use of medicine.

Obamacare, the most oppressive and obvious government/bureaucracy control of human lives in the United States, has now become the law of the land. Thankfully, many states are now eviscerating Obamacare. The lone exception is California, where the legislature and executive branches are in fact doubling down on the government control and 'crony implementation' of medical care.

Prop 46 allows incompetent physicians to be held accountable by the actions of individual citizens. As a matter of ethical guidance, the entire medical profession has abandoned 'primum non nocere' and the ethical rules of the Hippocratic Oath.
